### I. Welcome & Roll Call

Antoine Wright, acting chair, opened the meeting and welcomed attendees. Antoine led a call of committee members, welcomed Sarah Myers as the new Western Maryland Citizen Representative. Sarah gave a brief introduction for herself.

Meg introduced Ali as the new representative from Maryland Dept. of Health. Ali introduced her role working in chronic disease prevention and walkability.

### II. Agenda Review and Approval of May Meeting Minutes

Antoine requested a motion to accept the minutes from the last meeting. Jim Titus moved to approve the minutes; Michael Jackson seconded. No objections.

### III. MDOT: WALKTOBER

Meg Young, standing in for Francine Waters, gave a presentation on Walktober. Meg gave some statistics about registrations and attendees for Walk Maryland Day and an overview of the Walktober events that have occurred so far. Meg also spoke about the Walkinar regarding "Complete Streets" and mentioned the three complete streets demonstrations currently taking place in Howard County, Hagerstown, and Bel Air. Yesterday's Walkinar addressed pedestrian access and safety. Meg spoke about how MDOT's Sidewalk Data Collaborative is working to close the gaps in sidewalk access. Information was shared about the last Walkinar of the month, featuring the Secretaries of several agencies on 10/31/2024.

Michael Jackson spoke about the previous day's Walkinar, he had a question that was unanswered regarding sidewalk clearing for snow and how it relates to walkability and accessibility for disabled people.

#### IV. MdTA: Bicycle and Pedestrian Facilities

Carl Chamberlin reviewed the existing MDTA Facilities (Thomas J Hatem Memorial Bridge - US 40, John F. Kennedy Memorial Highway I-95, Fort McHenry Tunnel I-95, I-395, Baltimore Harbor Tunnel I-895, Francis Scott Key Bridge I-695, Intercounty Connector/MD 200, William Preston Lane Jr. Memorial Bay Bridge US 50/301, Governor Harry W. nice Memorial/Senator Thomas "Mac" Middleton Bridge US 301). This year the legislature asked MDTA to look at all the existing and planned bicycle/pedestrian facilities that are in and around MDTA facilities. The project included data collection, development of mapping, stakeholder meetings, identification of planned bike/ped improvements, and cost estimation.

Carl reports on the project, then allows time for questions. In the report he reviewed the Fort McHenry Tunnel, the Hatem and Nice/Middleton bridge Operations, and the Bay Crossing Study. Jim Titus asks who maintains the trail along the ICC, Carl says that some portions are maintained by MDTA and some portions by Montgomery County.

Meg Young asks about the purpose of the cost estimate – "is it that if a local jurisdiction comes and says we're going to build this now you're just going to coordinate with them? Or is it in the event that you're rebuilding something, you have a general cost estimate about how to integrate and connect to those planned facilities?" Carl says it would be a little bit of both.

Patti asked if they had looked at what other states and justifications are doing with their pike/ped facilities for bridges?

Jon Korin asked about the authority's ability to fund and implement these types of projects given that this type of mobility does not generate toll revenue.

Carl was not able to fully comment but said technically bikes are supposed to pay on these facilities and that the issue will be considered throughout the planning process.

### V. SHA Purple Line

Joe Moges gave an overview on purple line project and multimodal/accessibility improvements. Over 16 miles of new bicycle facilities will be built throughout the purple line corridor including trail access points, bridges and paths. Stations and train cars will have bike parking, bike channels and ramps. Joe displayed a map showing upcoming improvements and trail connections along purple line.

Michael Evans asked about injuries to two individuals who were injured near purple line construction. He brought a section of 2012 Complete Streets guidelines to Joe's attention that states all projects should not degrade current bicycle accommodations. Michael said that currently on MD 193 there are degraded and destroyed bike lanes. He asked for a commitment of safe cyclist passage at this intersection by the end of 2024.

Joe responded and let him know the short term solution and the future plan for a bicyclist detour during a future phase of construction.

#### Old Business & Public Comment

Meg shared inquiries from MBPAC inbox, including maintenance of MD 450, request for TRAIN commission update, and a request for interview for TheWash.org.

Baltimore city is looking for public comment on the planned Wolfe/Washington bikeway. BMC is looking for public comment on the proposed Regional Bike Network project website. The website will go live November 1, 2024, comment will be open until January 10, 2025.

Nigel Samaroo reported for the Legislative Subcommittee, the next meeting will be in November. They will be reviewing biking bills but would like more walk and transit bills.

Bong asked Nigel to share a list of the bills they are currently looking at, Bong will share any bills that Nigel may be missing.

Marian Vessels reported for the Pedestrian Subcommittee. They have discussed Walktober and had a presentation from DHCD.

Meg presented the new Trails Subcommittee, whose mission is to advise MDOT Strategic Trails Plan and support trail projects across the state. Their first meeting was held on October  $9^{th}$ , next meeting will be December  $13^{th}$ . Meg reviewed the TAC meeting schedule and the MD State Transportation Trails Strategic Plan Overview.
