

# III. Baltimore Regional Transportation Board Presentation - Bike and Pedestrian Efforts



# IV. State Agency Updates

Patrick McMahon updated members on the new bikes on MARC policy and passed out updated schedules showing which trains bikes are permitted on.

Charles Glass updated members on the status of the American Legion Bridge and I-495/I-270 Widening Project. The public, private, partnership process will comply with anything that is in Maryland statute. MDOT is still gathering information on local and regional master plans, including looking into the American Legion Bridge. MDOT is also coordinating with VDOT on a proposed bike/ped facility under their NEXT project. Charles passed out printed copies of the 2019 Bicycle and Pedestrian Master Plan which was completed and approved by the Governor in January 2019.





Heather Ersts gave an update on several campaigns and initiatives underway in the Office of Tourism including the "Open for It" Campaign and the Great Allegany Passage Public Television Video.

Daniel Paschall provided an update on East Coast Greenway initiatives including the East Coast Greenway Trail Summit held on April 4 - 6, 2019.

# I. Welcome, Introductions & Approval of Minutes

Charles Glass, and Marty Baker opened the meeting and welcomed attendees. Introductions were made for those attending in person and on the conference call. The July 12, 2019 meeting minutes were approved.

# **II.** Moment of Reflection for Kim Lamphier

Jon Korin, Steve Green and Jim Titus shared their fondest memories of Kim Lamphier, a long-time bicycle advocate who passed away in August. John Z. Wetmore recorded Kim's Memorial Service on Saturday, September 14, 2019 and the video will be available soon.

# III. MDOT Regional Introduction

Nate Evans, transportation planner at MDOT (MDOT) The Secretary's Office (TSO) provided an introduction to MBPAC's theme of visiting various metropolitan planning organizations (MPO) across the state. Nate also provided context on how the Washington, DC region and MPO promote bicycle and pedestrian planning, and safety initiatives.

# IV. Bicycle & Pedestrian Planning at the MPO Level in the Washington, DC Region

Mike Farrell, Senior Transportation Planner, Metropolitan Washington Council of Governments gave a presentation on the various activities the Transportation Planning Board (TPB) undertakes to promote walking and biking. Notable information from Mike's presentation include:

 TPB's Bicycle and Pedestrian Subcommittee is comprised of subject coordinators of member jurisdictions to share information, host workshops and assist with longrange planning and TIP amendments.



- Visualize 2045 is a constrained long-range transportation plan which was recently amended to include transit station area improvements for pedestrian and bicycle improvements and to complete the National Capital Trails Network.
- TPB conducts the StreetSmart campaign, an education and law enforcement effort to reduce pedestrian crash injuries and fatalities.
- TPB assists with the annual Bike To Work Day celebration.

# V. National Capital Trails Coalition

Katie Harris, Trails Coalition Manager, Washington Area Bicyclist Association, gave a presentation how the National Capital Trails project strives to create an all ages and abilities trail network spanning the Washington, DC region. Notable information from Katie's presentation include:

- The National Capital Trails Network (NCTN) includes 456 miles of existing trails, 386 miles of planned trails and 11 priority trail projects with an additional 40 agreed-upon trail projects.
- In Maryland, the NCTN is located in Montgomery and Prince George's County with priority trail projects such as the WB&A Trail Bridge over the Patuxent River, Suitland Parkway Trail, Oxon Run Trail, Prince George's County Connector, Purple Line Trail and Montrose Parkway East Trail.
- The National Capital Trails Coalition is hosing a Trail Symposium on Thursday, November 14<sup>th</sup>.
- Following the presentation, the committee discussed developing the trail system along MDOT State Highway Administration (SHA) roadways. In recent years, Prince George's County declined a state-sponsored project along MD 704 (Martin Luther King, Jr. Highway) extending the WB&A Trail as the county would be responsible for post-construction sidepath maintenance. Those in attendance agreed that coordination of sidewalk construction and maintenance remains an issue requiring a comprehensive solution.

# VI. State Agency Updates & Public Comments MDOT TSO

- Marty Baker shared that MBPAC is in need of a chair. An open application process is available to all for both chair and vacant memberships.
- Nate Evans announced the FY202 MDOT Bikeways awards and program updates for FY2021 application process. MDOT TSO is also reviewing personal mobility devices for possible legislation during the 2020 General Assembly session.



• Francine Waters reported on 2019 Walk Maryland Day and plans for 2020 Walk Maryland Day on Wednesday, October 7<sup>th</sup>, 2019.

# **MDOT Maryland Transit Administration (MTA)**

 Patrick McMahon indicated that all possible MARC cars have been upgraded with bike racks. Additional MARC cars do not have bike racks due to constrained space and need to maintain ADA accessibility.

# MDOT Motor Vehicle Administration (MVA) Maryland Highway Safety Office (MHSO)

Jeff Dunckel announced that StreetSmart Look Alive campaign begins Monday,
 October 28, 2019 with enforcements trainings at crosswalks.

# **Maryland Department of Natural Resources (DNR)**

- Dan Hudson shared that the Western Maryland Railroad Trail (WMRT), Phase 4 is complete with a tunnel bypass.
- The Grist Mill Trail in Patapsco Valley State Park is open at Bloede Dam, but remains closed at Lost Lake and areas near the Avalon entrance.
- The Baltimore Metropolitan Council (BMC) is advertising a 30% design plan project for the Patapsco Regional Greenway from Elkridge to Guinness New Gate Brewery in Halethorpe.
- The Tuckahoe State Park trail project is nearing complete construction. The trail will be named the Frederick Douglass Rail Trail with the next possible phase in Talbot County from Easton to Cordova.

#### VII. New Business

John Wetmore inquired as to how bicycle and pedestrian improvements will be incorporated in the I-495/I-270 P3 project. Nate Evans shared that MDOT SHA is coordinating with area elected officials, planners and engineers to identify bicycle and pedestrian projects that will be incorporated in overall project. Additionally, several community meetings are being held throughout November 2019. Public comments and requests for associated improvements can be made at these meetings and well into 2020.

Steve Green indicated that the Garrett College Trail from campus to U.S. Route 219 needs an additional \$40,000 to design and construct the project. Steve requested that anyone with grant opportunities contact him to fill the funding gap.
