# I. Welcome & Roll Call

Jon Morrison, Chair of MBPAC, opened the meeting and welcomed attendees. Jon led a roll call of committee members. Nigel brought technical issues to the attention of Jon, mentioning that several members have had trouble joining the meeting today.

# II. Agenda Review and Approval of May Meeting Minutes

Jon requested a motion to okay the agenda. Meg briefly mentioned that the agenda is very packed today, with a number of presentations, business of shared emails from the MBPC inbox, and a more robust subcommittee report. Michael Jackson motioned to approve the agenda, seconded by Nigel Samaroo. Jon requested that the agenda be approved, and received ayes from Patti and Nigel, approved with no objections.

Jon motioned for approval of the minutes from May 3<sup>rd</sup>, 2024, meeting. Seconded by Antoine RJ Wright and Michael Jackson. No oppositions.

# III. MDOT: Updated Complete Streets Policy

Meg Young and Kandese Holford were invited to speak on the updated Complete Streets Policy, accompanied by slides. Kandese gave an overview how "complete streets" is defined in policy. This is a deliberate approach to planning, designing, and constructing street to be safe for all users. Kandese spoke about the policy being in reference to a context-sensitive network. Kandese also spoke about the Moore-Miller State Plan and the Maryland Transportation Plan and how they echo messages of equity, accessibility and safety for all. Key policy elements are Public Involvement, Objective Statement, Safety and Performance, and Multimodal Traffic Data. There will be a "hub" created to serve as one-stop-shop for complete streets where all of the modes can

find related resources. Patti asked if the training for complete streets be for SHA and other staff MDOT staff as well as the public, to which Kandese replied yes.

## IV. Walktober

Meg introduced Francine Waters who provided an update on this year's Walktober plans. Francine shared the updated Walk Maryland and Walktober logos. They are very close to finalizing the 5 "walkinars" for the month of October. They have received a proclamation from the Governor for Walktober as well that will be shared soon. Walk MD Day will be the first Wednesday in October and registration will begin later this month. This year Francine would like a member from MBPAC and from the Pedestrian Subcommittee to register as either a Sole Mate or a Walk Leader for one of the walks in. She also encourages each of the modes and the partners to have dedicated walks. Lt. Beck mentioned that the forensic science division loves Walktober and have encouraged her to lead walks, during National Forensic Science Week - it is well received in her circle. Jon asked if walk and roll to school day on October 9 will be incorporated. Meg responded saying that she had a conversation with MD Dept. Of Health and MD State Dept. of Education about making sure that schools are registering for walks. Francine added that schools are able to sign up for walk MD Day as well.

Francine added that Duwan Morris from Montgomery County and Betsy Schultz both will both be speaking about safe routes to schools during our Walkinar on 10th as well. Daniel asked if the walks will be posted online. Francine directed him to the Walktober website, where all of the walks will be listed by county.

Patti asked if the information for the school walks will be located on the Walktober page, Francine responded saying, yes, they will also be on the Walktober page accompanied with a link to information about walk and roll to school day. Jon mention that he is not seeing a link to a Walktober main page on health.maryland.gov., Francine said she can offer suggestions to the health dept. But we're looking at the end of July for full web updates. Meg corrected to early August. Daniel shared the link to register as a Walk Leader.

# V. Bicycle and Pedestrian Priority Areas (BPPA)

Shane Sarver introduced himself as a bicycle pedestrian planner with State Highway Administration here to speak on BPPAs. A BPPA is a designation made by SHA in areas that have high potential for bicycling and walking. These are areas where local jurisdictions have also shown a commitment to bicycling and walking. Subject to resource availability SHA will lead and fund the development of a BPA plan in partnership with our local partners. If there are no SHA roadways in the BPPA area, we can still make the designation, but we won't lead or fund the development of the plan. BPPAs are here to: coordinate with local, state, and private stakeholders. Align state and local planning goals, and to provide for innovative bicycle and pedestrian treatments. BPPAs are NOT here to: provide state funding for capital improvement projects, replace existing transportation plans and goals, or supersede existing bicycle and pedestrian guidelines.

## BPPAP (BPPA Plan) development includes:

Planning bicycle and pedestrian improvements with stakeholder input, land use plans, and master plans., identifying roadway geometric and operational recommendations to align state and local bike and ped planning, and estimating construction costs for proposed bike and ped treatments.

Local agency roles and responsibilities include: demonstrating local support for bicycle and pedestrian mobility, participating in state and coal workgroups for each designated BPPA, coordinating local community stakeholders and advocacy groups, and monitoring and evaluating outcomes.

Shane shared the program timeline: Application submitted between 9/3/24 and 10/31/24. Selection will be made by the end of the year. BPPAP will be developed during the first half of 2025. Applications for FY20226 will open in May 2025.

Shane shared the application selection criteria.

Opened the floor to questions:

Seth asked if SHA considered extending the definition to corridors.

Administrator Pines received a letter from Montgomery and Prince George's County planning heads and transportation heads asking similarly for context driven to define a transit corridor. Shane responded:

We don't want it to just be looking at the corridor we want.

We want to look at all of the connections to the corridor as well, if that makes sense.

# VI. Old Business & Public Comment

Meg announced that Baltimore Region Bike to Work Week and Metro DC Bike to Work Day were both successful, and registration numbers stayed steady. Recap video was played, floor then opened to questions. Jon suggested taking best practices from Metro Dc areas and apply them to the Baltimore region where possible. Meg reminded members that there is an MBPAC e-mail inbox, and it's received 2 emails since the last meeting. Patti suggested that some of the questions could but put in an FAQ online.

# VII. Cycling Without Age

Sandy Bishop presented information on cycling without age. This program uses volunteer pilots on rickshaws to bike seniors and people of all ages around cities. Sandy then reviewed the requirements to start a cycling without age chapter. There is a senior living facility called Brighton Gardens in Columbia, MD who is interested. Their location does not have an option for option for people on bikes to travel from the living facility to the residential street.

Sandy Announced a call to action for safe infrastructure, and for contacts of individuals interested in creating more cycling without age chapters in MD.

# IX. Subcommittee Membership, Schedule, Report Out

Meg introduced the Eastern Shore subcommittee chair, Patti Stevens.

Patti reviewed the vision, mission, work groups and schedule for her subcommittee. They have a website launch goal date of Spring 2025.

Legislative subcommittee chair, Nigel Samaroo presented a review of members, and an invitation for new members. Nigel then reviewed the purpose of his sub committee: to evaluate or propose legislation that involves vulnerable roads users and present them to the main committee. This committee will meet 1 month prior to main meetings.

Jon Korin reviewed bills under consideration for 2025 as well as bills that were not passed in 2024 and potential bill to be proposed in 2025.

Pedestrian Subcommittee chair, Marian Vessels reviewed their mission, membership, and schedule. Email Francine Waters or MBPAC inbox to join next meeting.

Meg announced the new Trails subcommittee that is still being formed, still in need of a chair and accepting members.

# X. Agency Updates.

Meg announced that there is a need for a new Dept. of Health Rep following a Christie's departure. No updates from MD State Police. No updates from Dept. of Commerce No updates from Dept. Of Planning.

Gabriel Rose from MD Dept. Of Education announced that the physical education curriculum coordinator, Jason Seminoff, has mentioned numerous times that there are schools across the state that are looking to implement bike training for elementary school kids.

Sandy Olek from Dept. Of Natural resources provided updates on the Western MD rail trail and announced the first ever outdoor recreation summit in the fall, October 9th, 10th and 11th at Rocky Gap State Park.

Bong Delrosario from Dept. Of Disabilities shared the continuation of closely working with MTA customer revelations, and the new DEI dept.

Michael Jackson of MD National Park and Planning Commission provided the following updates:

# Mongomery County

Eli Glazier reported that Montgomery County's proposed bikeway wayfinding sign design is undergoing a major reset due to conflicts with the 2023 Maryland Manual for Uniform Traffic Control devices. Mongomery County's pedestrian master plan is now available to view online. Mongomery County's planning dept was awarded a transportation and land use grant to develop a vehicles mile traveled software to application which will be used to calculate estimate of vehicle miles traveled. This will be developed in June 2025.

## Prince George's County

On July 10th, Prince George's County Council member Eric Olson unveiled a conceptual proposal to create an East-West active transportation corridor that would be in the northern part of the county and connect 4 North-South shared use trails and the New Carrollton metro station.

Meg announced that the Complete Streets Leadership Academy is underway with 3 demonstration projects in progress. She also mentioned that TAP and Carbon Reduction Program awards will be announced in late August or September 2024.
