#### I. Welcome & Introductions (10 min)

The meeting began at 9:05 AM with Jon Morrison welcoming attendees. Nate Evans stated that the meeting is being recorded and lead a roll call of committee members with a quorum established.

#### II. Agenda Review and Approval of Minutes (5 min)

The agenda was reviewed with no revisions. Jim Titus motioned to approve the October 28, 2022 meeting minutes. Antoine RJ Wright seconded the motion and the minutes were unanimously approved.

#### Kim Lamphier Bikeways Network Program (25 min) III.

Nate Evans, Maryland Department of Transportation (MDOT) Active Transportation Planner, provided a history of the Kim Lamphier Bikeways Network Program and answered audience questions.



### IV. Old Business & Public Comment (10 min)

Nate Evans provided a follow-up on Mike Evans's redesign request for the MD 193 intersection of Campus Drive with Purple Line improvements. Nate relayed that MDOT State Highway Administration (SHA) and Maryland Transit Administration (MTA) officials have worked with Mike in the past to address his concerns. Several design changes were made, including adding bike lane buffers and travel lane narrowing, but the angle at which the bike lane crossed the transit tracks could not be mitigated.

Jim Titus expressed concern that SHA would design a bike lane with a known hazard. Marty Baker pointed out that it is not always possible to remove all known hazards associated with a multimodal roadway design. Eli Glazier expressed similar concern experienced in Montgomery County. Marty Baker said that similar conditions exist related to surface running light rail in Baltimore, and that people riding bicycles are required to exercise caution to navigate the crossing safely. The committee is interested in understanding what mitigating factors can be provided to improve transit track safety for bicycle traffic.

Daniel Paschall shared that the East Coast Greenway is encouraging federal legislation to create the Chesapeake National Recreation Area in an effort to improve walking and biking access around the Bay.

Peter Gray shared that Bike Maryland/WABA will host the Bike Symposium on Wednesday, February 8<sup>th</sup> in Annapolis. Registration is encouraged as space is limited.

Jon Morrison shared the final draft of the 2022 MBPAC Annual Report. Jim Titus motioned to approve the annual report. Antoine RJ Wright seconded the motion. The report was unanimously adapted.

# V. MBPAC Subcommittee Reports (15 min)

The Disability Subcommittee did not provide an update.

The Eastern Shore Subcommittee is partnering with the Eastern Shore Land Conservancy (ESLC) to support the Chesapeake National Recreation Area to in turn support regional trail development. The Rural Maryland Economic Fund awarded Worcester, Wicomico and Somerset Counties a grant to develop a regional trail plan. The Maryland Coast Bike Festival will be held May 6, 2023. <a href="https://marylandcoastbikefestival.com/">https://marylandcoastbikefestival.com/</a>

The Legislative Subcommittee did not meet this quarter but will schedule a meeting to coordinate review of legislation as it develops. Jon Korin noted several bills have been introduced which will have an effect on walking and biking in the state:

- 1. Safe Roads for All (SB16/HB70)
- 2. Equity in Transportation (SB19/HB9)
- 3. Reduction of Speed Limits by Local Authorities (HB94)

Other bills to be introduced include allowing bikes on sidewalks, stop as yield (Delaware Stop), as well as increased funding for active transportation projects and Acting Secretary Wiedefeld's nomination hearings.

Pedestrian Subcommittee lead staff Francine Waters noted that the subcommittee's annual goals were achieved as indicated in the MBPAC annual report. The subcommittee will meet again on March 16.

Nate Evans provided an update for the Bicycle & Pedestrian Master Plan Subcommittee indicating that the project's website is live https://www.2050marylandbpmp.com/ and shared the project's outreach schedule.

#### VI. Partner Agency Updates (20 min)

Gabriel Rose from the Maryland State Department of Education (MSDE) shared that the department is partnering with the Federal Motor Carrier Safety Administration in an effort to reduce student travel fatalities. <u>SB95</u> would require county boards of education to identify pathways to certain public schools.

Andrew Mengel from the Department of Natural Resources noted that Land & Wildlife Conservation Fund grants will be available upon notice from the National Park Service.

Eli Glazier from the Maryland National Capital Parks and Planning Commission shared that the Montgomery County Pedestrian Master Plan is being finalized and published next week.

Cynthia Spriggs from the Maryland Highway Safety Office (MHSO) shared that Highway Safety Grant application are now open (How to Apply for Highway Safety Grants - Tips & Recommendations -Zero Deaths MD). The Maryland Safety Summit will be held on Wednesday April 12 and MHSO completed the National Highway Traffic Safety Administration (NHTSA) bicycle and pedestrian safety assessment.
