I. Welcome/Introductions

Jon Morrison, Chair of MBPAC, opened the meeting and welcomed attendees. Meg Young led a roll call of committee members with a quorum established.

II. Agenda Review and Approval of January Meeting Minutes Approval

The agenda was shared on a PowerPoint. It was suggested that this becomes the standard process for MBPAC meetings. Feedback on the guiding powerpoint was welcomed by the Maryland Department of Transportation (MDOT) staff.

Jim Titus motioned to approve January meeting minutes, Nigel Samaroo seconded, and the motion to approve passed without objection. Minutes will be added to the MBPAC website.

III. Meg Young Introduction

Meg Young was introduced to the committee as the new Deputy Director of the Office of Active Transportation and Micromobility (OATM) at MDOT. She brings 10 years of experience from the Federal Transit Administration, Baltimore City, and the City of New Orleans.

The committee also wished a fond farewell to the outgoing Bicycle Planner, Nate Evans, who moved to a position as an Assistant Division Chief at the MDOT State Highway Administration.

IV. Annual Report Adoption

The MBPAC annual report, previously viewed in draft form at the January meeting, and a revised final report was emailed to MBPAC members was brought forth for discussion and approval. Jim



made a motion to approve the annual report, the motion was seconded by Kristy, and the motion passed with no objections. The report will be posted online and sent to agencies. Chair Jon Morrison added a note that MBPAC hopes to adopt the upcoming 2024 report by January in 2025.

V. OATM Project Update: Sidewalk Data Collaboration

OATM gave MBPAC an update on the Sidewalk Data Collaboration Project, with Marshall Stevenson from SHA leading the presentation. This project aims to collect sidewalk data into the One Maryland One Centerline (OMOC) database. The project is modeled after Level of Traffic Stress (LTS) but is more complicated due to the longer history of sidewalks across the state.

A question was asked as to whether of not pavers count as sidewalk. Sidewalks constructed with pavers would be classified as a sidewalk, but under the tier 3 of schema, this would be noted along with the ADA compliance of that sidewalk.

Jim suggested that the maintenance responsibility of the sidewalk be included, noting some frustration around the maintenance of sidewalks on state routes.

VI. 2024 General Assembly Legislative Session Review

Jon Korin, a member of the legislative subcommittee, gave the legislative session review. The summary can be found here: https://www.bikemaryland.org/2024-legislative-update-part-2/

For the 2025 session, an update to MBPAC meetings was suggested so that there will be a meeting during session to allow for greater input and possible action on pending legislation.

- Kristy proposed a legislative subcommittee meeting.
- Jon replied that does not allow for a vote for official guidance to the administration, but perhaps a subcommittee meeting could precede the greater committee meeting.
- Jim asked if SHA/MDOT could pose questions to MBPAC for comments on legislation

The review concluded with a 2024 session highlight summary:

- Jon K noted it was a strong session with a coalition of advocates working together. Collaboration with Executive Branch and Pillar Helm at MDOT was particularly notable and helpful. DNR also provided collaboration on the Trails Act.
- Seth shared about the better bus act and the enforcement of bus lanes as a notable accomplishment.
- For 2025, MBPAC is hopeful MDOT will put in for an e-bike program and requested a meeting with Pillar's replacement.

VII. Old Business & Public Comment (10 min)

 Old business- Jim brought up the issue of shared use path maintenance, specifically the trail on 450 in unincorporated PG County.



- Jim will send his Service Request ticket to MBPAC inbox.
- Michael Jackson asked for the average costs of sidewalk maintenance, which would help local jurisdictions and the state plan for maintenance
- Emails to the MBPAC inbox were shared. Several emails were received about the Francis Scott Key (I-695) Bridge rebuild, one inquiry was about children's bike safety in Howard County, and other emails were from the Governor's Appointments Office.
- Daniel Pascall, representing the East Coast Greenway (ECG), shared that the WB&A bridge is opening this year
- A list of Public Events was shared by MDOT:

- Jon Korin, representing Bicycle Advocates of Annapolis and Anne Arundel (Bike AAA), shared about the Jones Station trail signage, which will unveil a trail sign at the confluence of several regiona trails on May 29th.
- Seth Grimes, representing the Washington Area Bicyclists Association (WABA), shared an event on May 18 which will feature Joe Moges from MDOT SHA on a panel about addressing equity in bike infrastructure

VIII. MBPAC Subcommittee Reports (15 min)

- Eastern Shore Subcommittee update provided by Owen Bailey
 - Work on Trail planning is underway on the Eastern Shore.
 - 6 of 9 counties on the Eastern Shore joined a Trails Day Proclamation
 - A survey was shared at trails day, to be used to reach out to towns and counties, in hopes of creating interest groups like in Queen Anne's and Talbot County
 - National Park Service is providing technical assistance for trails plans
 - Queen Anne's County just issued the first bike-ped master plan on the eastern shore, Worcester County is scoping one and Talbot County is considering scoping a plan.
 - Michael Jackson shared that Cecil County has an older plan which was funded by WaMAPCO about 10 years ago. Owen going to look it up.
- Legislative Subcommittee covered in Agenda item VI
- Pedestrian Subcommittee update provided by Marian Vessels



- June 20th is next meeting of the pedestrian subcommittee Jon notes these are all open to the public
- MDOT is preparing for WALKTOBER 2024 with many of the same partners from years past
- Trails Subcommittee- Meg Young announced that MBPAC is taking interest to join the new Trails Subcommittee

IX. Partner Agency Updates (20 min)

- Department of Health Emailed update- The Maryland Department of Health Center for Chronic Disease Prevention and Control will continue the Walk Maryland Day activities, which will take place on October 2 this year, which is in collaboration with MDOT's Walktober events. The Center is also planning more Safe Routes programming this summer, and we are hoping to integrate into at least two new communities. The Center is also planning the Walkability Academy, which will be a modified version, probably a one-day event, we will provide more information to the committee.
- Department of Disabilities Bong Delrosario shared the department has been contacted to be involved in FSK rebuilding efforts.

- Department of Commerce- no updates
- Department of Planning emailed update partnering for WALKTOBER
- Department of Education no updates
- Department of Nature Resources emailed update partnering for Trails Plan
- Maryland National Park and Planning Commission Michael Jackson shared updates:
 - Department is hosting pit stops for Bike to Work Day (B2WD)
 - Montgomery Put out a great flyer, recapping bikeways constructed and funding, bike parking (100s at purple line), Might be a model. Oct 2023 ped master plan published. Carol Highlands safe mobility study completed, noting pedestrian MD 193 deadly intersection.
- MDOT updates from Meg Young
 - Everyone is encouraged to take advantage of the Commuter Choice program in the midst of FSK recovery. MDOT is busy calling businesses and encouraging mode shift with the increased traffic.

I'm thinking about the varying walkability of roads with no sidewalks for the gaps between walking facilities. Adding shoulders go a long way as a shorter term safety improvement for both pedestrians and cyclists. See the varying stress of the ECG on road route through Harford and Baltimore County in particular.

[5/3 9:44 AM] JimT (Guest) - Just for the records I'll summarize. Please try to include attributes that define who is responsible for maintenane, and the basis for such responsibility. Along a state highway, the responsibility may be the locality (if built under 8-630 or 8-631), or SHA (if it was build beore 8-630 enacted in some areas), or split between SHA and a private landowner (e.g. old sidewalk in locality that assigns some responsibility to private landowner). Often the answer my be unknown. This would help because SHA often just refuses to maintain on assumption that this is local responsibility--but that is not always true!

[5/3 9:45 AM] Seth Grimes, WABA -Meg, adding to my comment: In Montgomery County, pedestrian improvements are planned or underway in conjuction with BRT construction (MD 355, MD 586/Veirs Mill Road, other), and Purple Line construction (MD 320/Piney Branch Road, MD 193/University Blvd.). Similarly in Prince George's County: MD 193, MD 410, ...

And Baltimore actually does permit some e-bikes on sidewalks on roads 30mph and over--but only rental e-bikes. It makes more sense for it to be consistently applied to all e-bikes and bikes imo.
