

State Freight Advisory Committee (SFAC) Charter

Goal: to represent the freight community at large and advise the State on freight-related priorities, policies, issues, projects, and funding needs in order to advance freight Goals and Objectives in Maryland.

Objectives:

1. Support State Freight Plan Update
2. Provide feedback on freight project prioritization.
3. Provide guidance on freight program activities.
4. Communicate freight experience and bottlenecks.
5. Advise on next generation supply chain operations and how the State can support industry.
6. React to Freight Performance and advise on solutions to address bottlenecks.

Sponsor: Jeffrey Hirsch, Assistant Secretary for Transportation Policy Analysis and Planning, Maryland Department of Transportation (MDOT)

Facilitation: The group would not have a formal chair but will be led by the sponsor and all meetings facilitated with staff/consultant support.

Role of the State Freight Advisory Committee:

1. Advise the State on freight-related priorities, policies, issues, projects, and funding needs;
2. Serve as a forum for discussion of State transportation decisions affecting freight mobility;
3. Communicate and coordinate regional priorities with other organizations (for example, among state, regional and local planning organizations);
4. Promote the sharing of information between the private and public sectors on freight issues;
5. Participate in the development of the State freight plan, and other relevant freight plans;
6. Provide recommendations for Critical Urban and Rural Freight Corridors, which should be done as part of the State freight plan process; and
7. Review and provide guidance on freight-related performance measures and performance data.

Frequency of Meeting: 2-3 times per year, 1st Wednesday of **April** and **October (proposed revision to avoid summer/winter)**, each year, 2:00-4:00 pm, virtually or at MDOT TSO Offices, with an additional meeting virtually, as needed.

Boundaries:

1. Everyone will be respectful of each member, taking turns speaking, etc.
2. Criticism will be constructive, and positive in nature.
3. Members cannot recommend anything that would violate Maryland statute or be seen as unethical.
4. Everyone must agree to add agenda items that are in line with the role of the SFAC.

Membership Duration

- Annually, each member will assess whether they remain in a position to serve on the SFAC.
- Annually, MDOT will assess membership to determine if changes in membership would benefit the SFAC.
