

The MDOT State Highway Administration (MDOT SHA) hereby requests an amendment of the FY 2023-2026 BRTB TIP to add right-of-way acquisition and construction funding to an existing project.

ANALYSIS

MD 24: South of Stirrup Run Culvert to Deer Creek Bridge, Section G (65-1601-12) – This requested amendment reflects the addition of approximately \$6.0 million for MD 24 (Rocks Road) section G improvements from south of Sharon Road to north of Ferncliff Lane. This amendment adds \$67,000 to design, \$165,000 to right-of-way acquisition, and \$5,804,000 to construction funding in the FY 2023-2026 BRTB TIP. The project will improve safety by remediating slopes supporting MD 24, repairing pavement, improving roadway drainage, and addressing roadside safety. The total cost of the project is \$9.0 million, including funding programmed prior to and subsequent to the FY 2023-2026 BRTB TIP. The MDOT SHA anticipates beginning construction in the Spring of 2023 with work proceeding through 2025.

The attached Statewide TIP (STIP) report documents MDOT's requested amendment with respect to funding for the above project. This requested action will not impact scheduling or funding availability for other projects in the current STIP, which remains fiscally constrained. The amended funding does not affect the portion of federal funding programmed for transit or allocations of state aid to local jurisdictions in lieu of federal aid.

In addition, the Maryland Transportation Trust Fund (TTF) remains fiscally constrained. The TTF supports State transportation system operation and maintenance, MDOT administration, debt service, and capital projects. Semiannually, MDOT updates revenues and expenditures using two national forecasting companies' latest economic estimates. The MDOT published funding details in the Draft FY 2023-2028 Consolidated Transportation Program and FY 2022-2025 Maryland STIP.
