To request the MDOT OPCP approve and forward to the Federal Highway Administration (FHWA) for its approval the following STIP amendment.

SUMMARY

The MDOT State Highway Administration (MDOT SHA) hereby requests amendment of the FY 2022-2025 Maryland STIP on behalf of St. Mary's County to reflect the following action.

Replacement of Bridge no. SM0001010 – This requested amendment reflects the addition of a new project and \$218,000 in STBG funding to the FY 2022-2025 STIP. Built in 1970, this bridges' overall length is 40'-10", with a roadway width of 13'-4". The superstructure consists of five BP 14 x 102 painted steel beams supporting a timber deck comprised of transverse 8" x 12" plan sections bolted to longitudinal 4" x 8" timber nailers that bear on the top of the steel beams. The substructure consists of timber piles with 10" x 10" timber caps and timber wing walls. The most recent inspection returned the following ratings: Deck (6), Substructure (5), Superstructure (4). The bridge is nearing the end of its useful life.

The attached STIP report documents MDOT's requested amendment with respect to funding for the above project. This requested action will not impact scheduling or funding availability for other projects in the current STIP, which remains fiscally constrained. The amended funding does not affect the portion of federal funding programmed for transit or allocations of state aid to local jurisdictions in lieu of federal aid. St. Mary's County is the lead for the project. The project is funded by IIJA STBG funds that are set aside specifically for local bridges. The 20 percent match is being provided by St. Mary's County.
