SUBJECT: REQUEST FOR AN AMENDMENT TO THE FISCAL YEAR 2025-2028
STATEWIDE TRANSPORTATION IMPROVEMENT PROGRAM (STIP)

PURPOSE OF MEMORANDUM

For OPPPD to review and submit the following to the Federal Transit Administration (FTA) to amend the FY 2025-2028 Maryland STIP. This amendment adds \$2,146,000 in 5310 funds split evenly (\$1,073,000) in both FY 26 and FY 27. The action also moves the FY 25 funding to FY 26. The amendment also adds \$1,268,000 in state/local match, split evenly (\$634,000) in FY 26 and FY 27. Finally, it moves the match from FY 25 to FY 26. This action replaces Amendment replaces Amendment #25-15, which was never approved by FTA.

ANALYSIS

The Capital and Operating Program Assistance to Private Non-profit Agencies for the Transportation of Elderly and Persons with Disabilities program enhances mobility for seniors and persons with disabilities by providing funds for programs to serve the special needs of transit dependent populations beyond traditional public transportation. This amendment adds \$2,146,000 in 5310 funds split evenly (\$1,073,000) in both FY 26 and FY 27. The action also moves the FY 25 funding to FY 26. The amendment also adds \$1,268,000 in state/local match, split evenly (\$634,000) in FY 26 and FY 27. Finally, it moves the match from FY 25 to FY 26. This action replaces Amendment replaces Amendment #25-15, which was never approved by FTA.

The attached Statewide Transportation Improvement Program (STIP) report documents MDOT's requested administrative modification with respect to funding for the project above. The requested action will not have an impact on scheduling or funding availability for other projects in the current STIP, which continues to be fiscally constrained.
