RE: 2014 Annual MDOT Tour Meeting
Town of Boonsboro Priorities

Dear Secretary Smith:

The Mayor and Council of the Town of Boonsboro look forward to your visit on October 16, 2014 to consider and discuss transportation priorities for Washington County and Its municipalities, including the Town of Boonsboro. Below please find a suggested list of priority items for the Town, as recommended by the Mayor and Council:

- 1. <u>US Alternate 40/Maryland Route 34 Intersection Phasing</u>: SHA's Office of Environmental Design commented in 2011 on the congestion in the Town Square for improvements to have minimal impact and begin with "sensor activated traffic signal directional staggering and timing." We respectfully request consideration is given to the comments from the Office of Environmental Design, and directional staggering and timing are implemented promptly at this extremely busy intersection to alleviate traffic.
- 2. <u>US Alternate 40/Maryland Route 67 Proposed Intersection Improvements</u>: We support the proposed roundabout, to be developed under the proposed development plan for the Preserve at Fox Gap. The Town recommends consideration be given to include two exit lanes from the new collector road in the development, as well as connectivity to the existing sidewalks along US Alternate 40 westbound.
- 3. <u>Transit Program:</u> The Town of Boonsboro supports the County's request for additional transit funding to serve its municipalities. Boonsboro, the county's second largest municipality, is not currently served by the County's bus system.
- 4. <u>Sidewalks and Trails</u>: The Town of Boonsboro thanks MDOT and SHA for providing programs and funding for sidewalks and trails, including the Safe Routes to School program. We advocate for Retrofit Sidewalk installation on US Alternate 40, as well as Safe Routes to School funding for the Boonsboro Educational Complex along Maryland Route 66.
