The Maryland Department of Transportation (MDOT) hereby amends the Fiscal Year (FY) 2019 – 2022 Maryland Statewide Transportation Improvement Program (STIP) to reflect the following changes for the Statewide Planning and Research Program to the highway section of the FY 2019 Statewide Transportation Improvement Program (STIP). The MDOT has designated this modification as Control #19-131, and the supporting documentation is attached.

This requested amendment reflects the addition of \$554,000 in design funding for the MD 413 Phase 2C Trail in Westover, MD. This includes \$443,000 in federal Transportation Alternatives (TA) Program funding and \$111,000 in State funding for this local public agency (LPA) project. The MDOT SHA is managing design of this LPA project, which will take place in 2021-2023. The Maryland Statewide Transportation Improvement Program continues to be fiscally constrained.

PURPOSE OF MEMORANDUM

The MDOT State Highway Administration (MDOT SHA) hereby requests amendment of the FY 2019-2022 Maryland STIP to reflect the following one action.

ANALYSIS

MD 413 Phase 2C Trail (SO1812) – This requested amendment reflects the addition of \$554,000 to SO1812 design funding in the FY 2019-2022 Maryland STIP. This includes \$443,000 in federal Transportation Alternatives (TA) Program funding and \$111,000 in State funding for this local public agency (LPA) project. The MDOT SHA is managing design of this LPA project, which will take place in 2021-2023.

The attached STIP report documents MDOT's requested amendment with respect to funding for the above project. This requested action will not impact scheduling or funding availability for other projects in the current STIP, which remains fiscally constrained. The amended funding does not affect the portion of federal funding programmed for transit or allocations of state aid to local jurisdictions in lieu of federal aid.

In addition, the Maryland Transportation Trust Fund (TTF) remains fiscally constrained. The TTF supports State transportation system operation and maintenance, MDOT administration, debt service, and capital projects. Semiannually, MDOT updates revenues and expenditures using two national forecasting companies' latest economic estimates. The MDOT published funding details in the FY 2021-2026 Consolidated Transportation Program (http://www.mdot.maryland.gov/newMDOT/Planning/CTP/Index.html) and FY 2019-2022 Maryland STIP (http://www.mdot.maryland.gov/newMDOT/Planning/STIP TIP/STIPandTIP.html).
