The Maryland Department of Transportation (MDOT) hereby modifies the Fiscal Year (FY) 2019-2022 Maryland Statewide Transportation Improvement Program (STIP) to reflect funding changes for a Harford County project that is contained in the FY 2020-2023 Baltimore Regional Transportation Board (BRTB) Transportation Improvement Program (TIP). The BRTB Executive Committee approved the modification to its TIP on January 28, 2020.

Enclosed is one Administrative Modification to the *2020 – 2023 Baltimore Region Transportation Improvement Program (TIP)* as approved by the BRTB Executive Committee on January 28, 2020. The documentation enclosed supports changes to the *2020 – 2023 TIP* for one Harford County project:

- **Chestnut Hill Bridge #40: 15-1101-13**

The Administrative Modification updates federal STBG funds in FY 2020 for the construction and other phases. The other phase funds are not new as they are for utility relocation work that is being completed as part of the construction of this project. This minor funding change is within the framework for an Administrative Modification.

The project is categorized as not exempt and is included in the conformity determination for the 2020-2023 TIP. Harford County has affirmed that fiscal constraint for their program of projects remains intact.

Pursuant to the prescribed Transportation Improvement Program MOU signed in 2014, the BRTB Executive Committee approved this change to the *2020 – 2023 TIP*.

Description:

This project will replace the existing Chestnut Hill Road Bridge. Three foot shoulders planned on both sides of the road.

Engineering funds were included in a previous TIP.

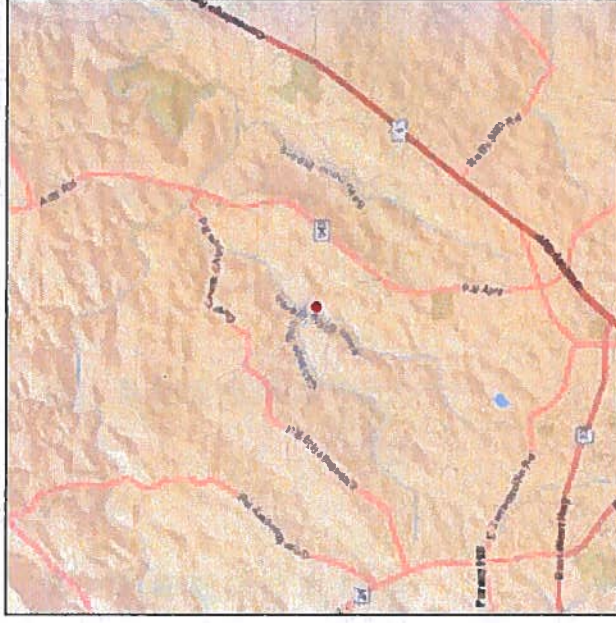
Justification:

The current structure is a single-lane bridge with a deteriorating superstructure and an inadequate waterway opening.

Administrative Modification: This administrative modification updates federal STBG funds in FY 2020. Construction phase funds increase by \$200,000 (\$160,000 federal/\$40,000 matching) to reflect recent increases in contractor bids on similar projects for items such as maintenance of stream flow, bridge foundations, and rip rap stone for scour protection. The construction work will also include \$123,000 in utility relocation work (\$98,000 federal/\$25,000 matching). These funds are added under the Other phase. Total funding in the TIP increases from \$1.38 million to \$1.703 million.

Connection to Long-Range Transportation Planning Goals:

2.A Improve and Maintain the Existing Infrastructure – Improve the condition of roadway systems (pavement, bridges, tunnels).

Dear Mr. Lang:

Harford County is requesting an administrative modification to the FY 2020-2023 TIP for the Chestnut Hill Road Bridge #40. Additional funds for this project are being included for FY 2020 for relocation of utilities and construction. FY 2020 federal utility funds are \$98,000 with a \$25,000 local match. FY 2020 construction funds are \$1,232,000 with a \$348,000 local match. Harford County is requesting an update to the funding of this project due to an increase in construction and utility relocation costs. These funds are being requested so that the FY 2020-2023 TIP accurately reflects the County Capital Improvement Program (CIP) budget for this project.
