The Maryland Department of Transportation (MDOT) hereby amends the Fiscal Year (FY) 2019 – 2022 Maryland Statewide Transportation Improvement Program (STIP). This amendment reflects the addition of Section 5304 funding to the statewide transit portion of the STIP. The MDOT has designated this amendment as Control #19-54.

This new category of funding will enable Transit Development Plans (TDP) to be completed by the Locally Operated Transit Systems (LOTS) throughout Maryland. These TDP’s will be used by the LOTS as a guide for implementing service and organizational changes, along with illustrating improvements and potential expansion. 
