The Maryland Department of Transportation (MDOT) hereby amends the Fiscal Year (FY) 2019 – 2022 Maryland Statewide Transportation Improvement Program (STIP). This amendment reflects the addition of funding to the highway portion of the FY 2019-2022 STIP. The MDOT has designated this amendment as Control #19-58.

The \$1,000,000 for the design, right-of-way acquisition and construction for the Grantsville Local Access Road project comes from designated Appalachian Highway Development System (AHDS) funding. The supporting documentation is attached.

PURPOSE OF MEMORANDUM

To request the MDOT Office of Planning and Capital Programming approve and forward to the Federal Highway Administration (FHWA) for its approval the following STIP amendment.

The MDOT State Highway Administration (MDOT SHA) hereby requests amendment of the FY 2019-2022 Maryland STIP to reflect the following one action.

ANALYSIS

Grantsville Local Access Road (AR2001) – This requested amendment reflects the addition of a new project to the FY 2019-2022 Maryland STIP and the addition of funding for this project. It reflects the addition of \$1,000,000 for design, right-of-way acquisition, and construction for AR2001, a locally-sponsored project funded with federal Appalachian Highway Development System funding. The project sponsor, Garrett County, anticipates beginning design in FY 2020 and construction in FY 2021.

The attached Statewide TIP (STIP) report documents MDOT's requested amendment with respect to funding for the above project. This requested action will not impact scheduling or funding availability for other projects in the current STIP, which remains fiscally constrained. The amended funding does not affect the portion of federal funding programmed for transit or allocations of state aid to local jurisdictions in lieu of federal aid.

In addition, the Maryland Transportation Trust Fund (TTF) remains fiscally constrained. The TTF supports State transportation system operation and maintenance, MDOT administration, debt service, and capital projects. Semiannually, MDOT updates revenues and expenditures using two national forecasting companies' latest economic estimates. The MDOT published funding details in the FY 2020-2025 Consolidated Transportation Program (<http://www.mdot.maryland.gov/newMDOT/Planning/CTP/Index.html>) and FY 2019-2022 Maryland STIP (http://www.mdot.maryland.gov/newMDOT/Planning/STIP_TIP/STIPandTIP.html).
