### 1. Introductions and Meeting Objectives

On behalf of MDOT, Stacy Cook of Cambridge Systematics welcomed the ARAC to the final meeting of the committee. Ms. Cook noted that the goal for the meeting was to finalize the ARAC measures, address any remaining questions or considerations for the measures, and review next steps for the 2019 AR report and Dashboard. The meeting was conducted using GoToMeeting and a conference call line.

## Section 4. ARAC Performance Measures Recommendations by Goal

### Comments on performance measures

 ARAC member Joel Dunn suggested providing more information on the Excellerator if measures are being borrowed from it. Noted the general public will not likely be familiar with the Excellerator. CS responded that the previous section on the Excellerator can include a bit more information and a link the MDOT Excellerator website.

- ARAC member Joel Dunn asked for clarification on the Wetland creation measures as to why it noted (Year 2000 and 10 years). CS noted that this will be changed to indicate that the measure should be reported only for a 10 year span, not since the year 2000 as reported in past years' reports.
- ARAC member Jennifer Toole noted that the method of calculation for ADA compliance should be checked, noting, that measure may want to refer to the percentage of sidewalks that have curb ramps that meet ADA, rather than total compliance. Very few sidewalks meet cross slope requirements (such as driveways). She suggested another measure for future consideration:
  - Percentage of State-owned roadway directional miles within urban areas that have sidewalks, and percent of sidewalks that comply with the Americans with Disabilities Act with regards to sidewalk width and the provision of curb ramps at intersections.

#### Future Measures – comments:

- ARAC member Joel Dunn noted that the area of the mitigation should be considered as a potential future measure. He suggested the following bullet:
  - Water Quality Treatment: standardized measures of estimated performance for delivery of ecosystem services (e.g. drainage area treated or lbs. of pollution reduced)
